

ABOUT THE JOURNAL

International Journal of Environmental Health and Technology (IJEHT) is an interdisciplinary, peer-reviewed journal covering all areas of environmental science and sustainable technology relevant to the applied science, medical and engineering communities. *IJEHT* publishes full length original papers, short communications, review papers, Technical reports, letters, and periodic to the Editor. Papers are welcome, which apply environmental principles to understand environmental processes, remediation and relevant health problems. The interdisciplinary approach of the publication ensures that the editors draw from researchers worldwide in a diverse range of fields. The journal aims to be a leading peer-reviewed platform and an authoritative source of original research and reviews related to environmental health and sustainable technology. The journal is publishing print and online versions on a bi-monthly basis (6 issues per year).

TYPES OF MANUSCRIPT

Short Communications: A Short Communication is suitable for recording the results of complete small investigations or giving details of new models or hypotheses, innovative methods, techniques or apparatus. The style of main sections need not conform to that of full- length papers. Short communications are 2 to 4 printed pages in length and should not exceed 4000 words.

Research Paper: These should describe new and carefully confirmed findings, and experimental procedures should be given in sufficient detail for others to verify the work. The length of a full paper should be the minimum required to describe and interpret the work clearly. Research Papers should not exceed 10000 words.

Review Paper: Submissions of review papers and perspectives covering topics of current interest are welcome and encouraged. Reviews should be concise and no longer than 10-12 printed pages and the length of Review Papers is will flexible but only critical review papers be considered.

Word counts include abstract, text, references, acknowledgments, figures and tables. The word count of each figure and table should be estimated based on 500 words equivalent for one printed page. *Perspectives* and *Letters to the Editor* are welcome but they should not exceed 500 words.

SUBMISSION OF RESEARCH MANUSCRIPTS

Online submission: Submit manuscripts in Microsoft word file by uploading your manuscript through Online Submission. Papers sent in PDF format will not be accepted. A manuscript number will be mailed to the corresponding author for further communication. For all other correspondence that can be sent by e-mail, please visit Contact Us section of the Journal.

Every manuscript should contain the Covering Letter, which includes the corresponding author's and coauthor(s)'s full address and telephone and should be in an e-mail message sent to the Editor, with the file. The authors should also suggest panel of five or more reviewer's contact details in the cover letter. The manuscript should prepare according to the Author Guideline of the journal and manuscript may be returned to authors that do not adhere to the Author Guidelines. **Submission Preparation Checklist:** As part of the submission process, authors are required to check off their submission's compliance with all of the following items, and submissions may be returned to authors that do not adhere to these guidelines.

- 1. The submission has not been previously published, nor is it before another journal for consideration (or an explanation has been provided in Comments to the Editor).
- 2. The submission file is in Microsoft Word file format.
- 3. Where available, URLs for the references have been provided.
- 4. The text adheres to the stylistic and bibliographic requirements outlined in the Author Guidelines, which is found in About the Journal.
- 5. If submitting to a peer-reviewed section of the journal, the instructions in Ensuring a Blind Review have been followed.

Submission of the Papers: Article submitted to the Review should be original contributions. Only original papers are considered for publication. The authors may be asked to declare that the manuscript has not been submitted to another journal for consideration at the same time. The submitting author is responsible for obtaining agreement of all co-authors as well as any sponsors required consent before submitting a paper. Responsibility for the content of a paper lays on the Authors and not on the Editors or the Publisher.

It is essential that authors prepare their manuscripts according to established specifications given in author guideline. Review Process: All published journal papers are refereed by the international competent researchers and scientists. Therefore, all manuscripts are reviewed by the editorial board and assigned reviewers who expertise in that area. The reviewer's recommendations determine whether a paper will be accepted/ accepted subject to change/subject to re-submission with significant changes/rejected. For papers, which require changes, the same reviewers will be used to ensure that the quality of the revised paper is acceptable. All papers are refereed, and the Editor reserves the right to refuse any typescript, whether on invitation or otherwise, and to make suggestions and/or modifications before publication. Decisions will be made as rapidly as possible, and the journal strives to return reviewer's comments to authors within 12 weeks. The editorial board will re-review manuscripts that are pending for revision. It is the goal of the journal to publish accepted manuscripts within 2 weeks after acceptance in both online and print versions.

PREPARATION AND SUBMISSION OF MANUSCRIPT

1. Cover letter: While submitting the manuscript the corresponding author (on behalf of all the authors) should send Cover Letter followed by list of 5-6 reviewer's address. Without the declaration/cover letter and 5-6 reviewers address (Name, Designation, Affiliation, Address, Email id, Specialization, etc.), the manuscripts are not considered for further processes and publication.

2. Title of the Paper (Calibri Font size - 16 point)

3. Name of the author(s) with initials and the name and address of the institution and email.

4. Abstracts (Calibri Font size - 10 point): An abstract of 200 to 250 words in Italics that sketches the purpose of the study, basic procedures; main findings its novelty; discussions and the principal conclusions, should not contain any undefined abbreviations or references.

5. Key words (Calibri Font size - 10 point): Provide maximum 6 keywords, which can be used for indexing purposes. Keywords should not repeat the words of the manuscript title or contain abbreviations and shall be written in alphabetical order as separated by semicolon. Abbreviations should be defined at first mention and used consistently thereafter through the text.

6. Text (Calibri Font size - 12 point, bold): The paper must contain preferably **1. Introduction, 2. Methods and Material, 3. Results and Discussion, 4. Conclusion and Acknowledgement:** including information on grants received, before the **References**, in a separate section. Subsections should be numbered 1.1 (then 1.1.1, 1.1.2, ...), 1.2, etc. (the abstract is not included in section numbering). Use this numbering also for internal cross-referencing: do not just refer to 'the text'. Any subsection may be given a brief heading. Each heading should appear on its own separate line.

7. Tables (Calibri Font size - 12 point, bold): Charts and Tables should be in MS Excel or MS Word and images in JPG format using maximum possible high resolution and should be numbered sequentially as they appear, *i.e.* **Table 1**, **Table 2**, etc.

8. Figures: Figures should be numbered sequentially as they appear, *i.e.* **Figure 1**, **Figure 2**, etc., and a caption should appear directly below each figure.

9. Mathematical Equations: Authors may create their mathematical equations by using equation editor.

10. Acknowledgements: Authors may acknowledge for the contribution, partial support, funding agency, etc

10. References (Calibri Font size - 12 point): References must be typed in the following order: Surname and initials followed by title of the article, name of journal in abbreviated (name of book in normal), publication year, volume no., page no. or standard Vancouver style referencing can be followed using any reference management tools (ex: Mendeley, Endnote, etc).

Citations must be numbered consecutively in brackets (1). The list of references should be arranged in the order of citation in text, not in alphabetical order. Reference to only published journal articles (1), textbooks (2), papers in conference proceedings (3), chapters in books (4), technical reports (5) and theses (6), should provide sufficient information as in the samples and unpublished references not to be cited in the manuscripts.

TERMS AND CONDITIONS FOR ONLINE SUBMISSION

IJEHT, GREENS publisher is committed to upholding the integrity of the scientific record. Maintaining integrity of the research and its presentation can be achieved by following the rules of good scientific practice, which include:

- The manuscript has not been submitted to more than one journal for simultaneous consideration.
- The manuscript has not been published previously (partly or in full), unless the new work concerns an expansion of previous work.
- A single study is not split up into several parts to increase the quantity of submissions and submitted to various journals or to one journal over time.
- No data have been fabricated or manipulated (including images) to support your conclusions
- No data, text, or theories by others are presented as if they were the author's own ("plagiarism"). Proper acknowledgements to other works must be given, quotation marks are used for verbatim copying of material, and permissions are secured for material that is copyrighted.
- Consent to submit has been received explicitly from all co-authors, as well as from the responsible authorities tacitly or explicitly at the institute/organization where the work has been carried out, before the work is submitted.
- Authors whose names appear on the submission have contributed sufficiently to the scientific work and therefore share collective responsibility and accountability for the results.
- Authors are strongly advised to ensure the correct author group, corresponding author, and order of authors at submission. Changes of authorship or in the order of authors are not accepted after acceptance of a manuscript.
- Adding and/or deleting authors at revision stage may be justifiably warranted. A letter must accompany the revised manuscript to explain the role of the added and/or deleted author(s). Further documentation may be required to support your request.
- Requests for addition or removal of authors because of authorship disputes after acceptance are honored after formal notification by the institute or independent body and/or when there is agreement between all authors.
